**The Price Bids shall be placed in a sealed cover clearly indicating “Price Bids for Hand Piece Cartridges”.All the three envelopes i.e. EMD Envelop, Pre-qualification Bid Documents Envelope, Technical Bid and Price Bids Envelope shall be placed in a sealed cover indicating “Quotations for Hand Piece Cartridges”.This sealed Envelope containing EMD, Pre-Qualification Bid Documents, Technical Bid Document and Price Bids Envelop shall be placed in the Tender Box kept in Room No. 08, Ground Floor of MAIDS Building upto 01:30 P.M 05<sup>th</sup> March 2013.**

**General Terms & Conditions:-**

1. The Quotations shall be filled only in prescribed Annexures given in the Tender document.

2. The supplies of the Hand Piece Cartridges will be for Maulana Azad Institute of Dental Sciences, MAMC Complex, Bahadur Shah Zafar Marg, New Delhi-110002. The rates should be quoted for F.O.R. destination (Without Taxes).
3. The validity of the quotation will be upto 31<sup>st</sup> March 2014. The Tenderer is bound to supply the store during the validity of quotation at the approved rates.
4. Only those Hand Piece Cartridges should be quoted which can be supplied by the firm within the period stipulated. The Cartridges shall be original and in its original pack.
5. The Supply period of Ordered Cartridges shall be 30 days from the date of issue of supply Order.
6. Penalty of 1% of the value of order per week for delayed supply shall be deducted subject to a maximum of 10% of the total value of the order from the bill raised by the Supplier or from the Security Money deposited.

In case of defective Hand Piece Cartridges, the same shall have to be replaced by the firm within one week failing which the Security Money/EMD Money deposited by the firm shall be forfeited and action may be taken against the firm as per rules.

**Payment shall be made on receipt of full quantities of the ordered Hand Piece Cartridges. No payment shall be made for Part Supply.**

7. The Tenderer should quote alongwith the Tender, his Permanent Account Number of Income Tax Department and VAT Registration No. in bold letter, on the body of first page of their Quotation as well as Mobile Number and e-mail address.
8. **Prices are to be quoted only in Indian Rupees.**
9. The decision of Price Evaluation Committee constituted by the Institute regarding approval of rates will be final and binding.
10. The rates should be quoted showing the prices total / pack price and taxes separately.
11. **The Tenderer will quote firm rates. No variation shall be allowed during the validity of rates.**
12. The quoted rates of items shall be same or lower as being supplied to other Departments / Institution / Organization / Hospitals. If it is found that these items are being supplied elsewhere on lower rates, difference shall be deducted from the bills and other necessary action as deemed fit shall also be taken against the Tenderer.

13. After the opening of Tenders there will be no correspondence between the firm and Institute till the tenders are finalized.
14. The rates quoted should be certified as the lowest quoted for any Govt. Department, in Delhi. If the price of any item is reduced due to any reasons during the validity of tender, the Tenderer will intimate the Maulana Azad Institute of Dental Sciences of reduced rates immediately and will charge reduced rates instead of rates instead of rates quoted / agreed.
